Background

Definition of Liquidation according to Kamus Besar Bahasa Indonesia is "the winding up of Company as a

legal entities that includes the payment of obligation to all creditors and distribution of remaining assets to the shareholders (Company)". The main purpose of liquidation is to perform any legal action and settlement of Company's assets which is wound up. The steps of liquidation shall be performed when a Company is wound up, in which the winding up company is not as result of merger and amalgamation. The company that has been declared to be wound up may not perform a legal action, unless it is required to settle all the company's assets in the event of liquidation.

Pledge of Shares

Law Number 40 of 2007 on Limited Liability Company ("Company Law") only recognizes the classification of registered shares. However, Article 53 paragraph (1), (2)
