Leks Legal Update

Executive Summary on New Minister of Finance Regulation on State Revenue

Background

In order to support the implementation of state revenue administration, it is necessary to refine the regulation regarding the Procedure of Payment and Transfer of State Revenue



by Import, State Revenue by Export, State Revenue by Excise Taxable Good (barang kena cukai), and State Revenue from the Administration Sanction on the Transport of Certain Goods, as stipulated in Minister of Finance of Republic Indonesia Regulation Number 213/PMK/04/2008 (“PMK 213/2008”). Therefore, on 5 February 2013, the Ministry of Finance has issued Minister of Finance of Republic Indonesia Regulation Number 30/PMK.04/2013 on the Amendment of PMK 213/2008 (“PMK 30/2013”). PMK 30/2013 is an implementing regulation of Law number 10 of 1995 on Customs (Kepabeanan), as amended by Law number 17 of 2006.

The Amendment

PMK 30/2013 has revised some of the clauses in PMK 213/2008, which is as follows:
