Guidance for Completion of Land Possession Previously Owned by Dutch Citizen or Dutch Legal Entity

Background

Under the Law Number 3 Prp of 1960, lands that were owned by Dutch citizens and have not been nationalized under Law Number 86 of 1958, is controlled by the state and will be granted to the



rights holder through sale and purchase ("**P3MB**"). Further, under the Presidium Cabinet of Dwikora Regulation Number 5/Prk/Year 1965, all buildings and lands owned by Dutch legal entities and have been abandoned by their directors/management is controlled by the state, and can be sold to the qualified rights holder ("**Prk5**").


