

New Features in Patent Law 2016

The Indonesia new patent law, namely Law No. 13 of 2016 on Patent ("Patent Law 2016"), was promulgated on 26 August 2016. The New Patent



Law is expected to increase the protection of patent in order to motivate inventors for making inventions. Since Independence Day of 1945, Indonesia has promulgated three patent laws, i.e. (i) Law No. 6 of 1989, as amended by Law No. 13 of 1997, (ii) Law No. 14 of 2001, and (iii) the Patent Law 2016.


