



Background

The government of Indonesia understands that the capital market plays a strategic role in the national development as one of the sources of funding for business and also as investment



instruments for Indonesians. Accordingly, to increase capital market's role, having a strong legal basis to ensure legal certainty of the parties conducting capital market activity in Indonesia and to protect the interests of public investor is imperative. Thus, the Law No. 8 of 1995 on the Capital Market ("Law No. 8/1995") was promulgated.


